Dear *Shri Dutta,*

Please refer to my D.O. letter of even number dated 28.2.2010 and D.O. letter dated 6.3.2010 from Director (SK) {copies enclosed} communicating target dates for submission of draft recruitment rules in respect of Group 'B' and 'C' non-Gazetted officials of Geological Survey of India. It is regretted that till date proposed draft recruitment rules as per guidelines issued by the Ministry have not been received.

2. Further direct recruitment for non-gazetted Group B and C posts of GSI through Staff Selection Commission (SSC) was to be taken up with SSC. Both these works were initiated in association with Shri M.N. Mugadur, DDG (P) and Director (SK), but till date no progress has been informed to the Ministry despite revising target dates. Further more, till date no proposal regarding anomalies of pay on implementation of 6th CPC have been received.

3. I shall be grateful if you could look into the matter personally and seek explanation of concerned officer(s) for the delay and expeditiously send the status report and proposals on these matters.

4. I would also be grateful if my D.O. letter could be acknowledged and responded to at the earliest.
